


First Few Months as ISSDA President



Gunfire erupts

"Shots fired! Officer down!"

Shortly after the Tuesday, Oct. 30, Maynard Savings Bank robbery, a large number of Fayette County emergency personnel were among the many local, state, and federal authorities who answered that call.

"When you hear those words, everyone is put on high alert, and each of us (in law enforcement) wants to respond as quickly as possible," said Fayette County Sheriff Marty Fisher on Thursday. "All of us wanted to be there to offer assistance, but at the same time some of us were duty-bound to remain behind and take care of other portions of the investigation."

In addition to three tellers and the bank manager, there was one customer and a child present when the bank robbery was reported at Maynard Savings Bank at approximately 11:15 a.m. on Oct. 30.

The two suspects, Jeremiah Mumford of New Hampton and William Clayton of Osage, allegedly entered the bank with fully loaded assault rifles, and robbed the staff at gunpoint before escaping with \$15,000.

A description of the suspects and vehicle was quickly relayed to area law enforcement with a request to be on the lookout.

Fisher confirmed that all available Fayette County Sheriff's deputies were among the law enforcement officials to answer the initial call. The local sheriff explained that a short time later, a Westgate firefighter spotted the suspects' vehicle in Fayette County. The volunteer fireman's vehicle was fired upon and struck six times.

Fisher joined Deputy Joe Miller and Sergeant Allen Henderschott in pursuit of the suspects.

While Chief Deputy James Davis maintained safety and secured the crime scene in Maynard, other deputies are credited with securing and preserving additional areas along the route of the crime spree.

At the intersection of 130th Street and

Y Avenue (Fayette/ Bremer county line), Miller was fired upon. The deputy later explained that he pursued the suspects for nearly two miles before his patrol car was disabled due to taking a bullet to the engine block.

Miller soon resumed the chase after hopping into Henderschott's vehicle, who had been trailing Miller by approximately three miles.

The two sheriff's deputies prepared to set up a road block at Sable Avenue and Highway 93 in Bremer County, but before being able to lay out stop sticks, they were confronted once again by the fleeing robbery suspects.

Gunfire was exchanged, with Henderschott taking cover near the front driver's side door. Meanwhile, Miller sought cover behind the opened trunk on the passenger side of the patrol car. During the exchange of gunfire, a bullet pierced the opened trunk near Miller.

At the same time, Fisher and members of the State Patrol were approaching the pursuit from the north. As reported by the Iowa Department of Public Safety, the

suspects repeatedly fired shots at pursuing vehicles.

Sumner Police Chief Dennis Cain was shot in the hand, thumb, and neck. He was transported by LifeFlight to an eastern Iowa hospital. According to the report, Chief

Citizen Heroes Bill & Lois Hall Recognized at 2012 Iowa-Nebraska Football Game

An Omaha, Nebraska, man and a couple from Clinton, Iowa, represented their respective states as "citizen heroes" when the University of Nebraska Cornhuskers met the University of Iowa Hawkeyes on Nov. 23 in the second-annual Heroes Game, presented by Hy-Vee. The Heroes Game uses the national stage created by this Big Ten football rivalry to honor the heroic efforts of individuals and organizations in America's heartland. Fans of both schools were invited to nominate residents of Iowa and Nebraska who have performed extraordinary acts of heroism and service in their communities. From among those nominated, staff and volunteers from the American Red Cross selected the following winners, who were recognized during a halftime ceremony on the field in Iowa City's Kinnick Stadium: Jason Parks of Omaha was driving to work one morning when he witnessed a collision between two semitrailer trucks. He rushed to the scene of the accident and, with no regard for his own safety, pulled one of the drivers from

the flaming wreckage only moments before the truck exploded.

Cain underwent surgery and remained in critical, but stable condition.

In addition, Iowa State Trooper Mark Domino was shot in the arm. He was later transported to an area hospital, treated and released.

At approximately 12:20 p.m. on Oct. 30, the two suspects abandoned their vehicle near Heartland Quarry west of Frederika. The pair fled on foot into a wooded area nearby. At that time law enforcement established a two-mile-long perimeter to ensure the suspects could not travel outside of the immediate area.

"Throughout the chase the suspects didn't get too far before they found themselves being pursued by another agency. They were boxed in fairly quickly," said Fisher.

"I was so impressed with the quick response of every level of law enforcement," Fisher continued, while explaining, "From the local police departments, who either participated in the pursuit itself or watched for the suspects while continuing to maintain safety in their respective communities, to the FBI agents from the Waterloo and Omaha areas, to State Patrol Posts 8, 9, and 10, who even had a plane in the air and the vehicle spotted before the two suspects reached the Bremer County line – I don't think we could have trained as well as the response went."

Throughout the remainder of the afternoon and into the evening, law enforcement from more than 16 federal, state, county, and local agencies reportedly worked to locate the alleged bank robbers.

Iowa State Patrol tactical teams methodically searched and cleared the area north and west of Frederika, where Mumford and Clayton were suspected to be hiding. Then at approximately 7 p.m., Waterloo police officers who were working on the perimeter of the search area apprehended Mumford and Clayton.

The men were attempting to escape the search area and evade officers by crossing County Road V5C, approximately three-quarters of a mile north of Frederika. Once spotted, the two men surrendered without incident.

"The quick response and resulting arrests started with the bank employees, who followed the proper protocol," said Fisher. "It continued with community members and rural residents, who responded to our needs and allowed the numerous law enforcement agencies to do our jobs."

"We're just so very lucky," he concluded. "We could have had a hostage situation or, even worse a loss of life. We are all so thankful that no one was killed."

Linn County Deputies Receive Commendation Awards

In the evening of July 25, Linn County Deputies Shawn Ireland, Alan Johnson, Casey Sanders, Brad Campbell and Sgt. Andy Humphrey responded to a call on a possibly suicidal woman in her 20s on a cliff at the Palisades-Kepler State Park near Mt. Vernon.

The deputies located the individual's vehicle as the sun was setting and, after a short search, found her sitting on a cliff 25-30 feet above the ground with her legs dangling over the edge. Deputies Ireland and Sanders, along with DNR Park Ranger Jim Hansen, stayed on top of the cliff with the woman while Deputy Johnson, accompanied by a Mt. Vernon Police Officer Steve Moel, went below her with Deputy Johnson and Officer Moel, using their flashlights to illuminate her for those topside.

As emergency responders attempted to talk with the woman, Deputy Ireland retrieved a rope from his patrol vehicle and repositioned his car closer to the scene. He then tied one end of his rope to the railing, and Ranger Hansen, who was standing between the woman and the railing, tied the other end around himself. This allowed Ranger Hansen to get closer to her without the fear of falling. Deputy Ireland used a calm, reassuring voice to attempt communicating with the woman, but the distraught

and irritated woman refused to talk. Fearing the woman would jump, Sgt. Humphrey contacted on-scene fire fighters and coordinated placing something near the base of the cliff to help break the woman's

fall in the event she jumped. Without any warning, the woman then attempted to jump off the cliff.

Ranger Hansen grabbed one of the woman's wrists and Deputy Sanders the other. Deputy Ireland held onto the rope and prevented them from falling, but was unable to pull them to safety.

With Sgt. Humphrey's assistance, they were able to pull the woman to safety. During the entire incident, Deputy Johnson lit the area from below, allowing the rescuers to safely assist the woman back over the ledge. Deputy Campbell assisted where needed during this incident, and after the rescue assisted with her medical care as the Rescue 57 Paramedic-Specialist that day.

Without the quick and heroic actions taken by Deputies Ireland, Sanders, Johnson, Campbell and Sgt. Humphrey, along with Ranger Hansen and Officer Moel, the outcome of this incident would have been much different. They likely prevented the woman's death. For their actions, Sheriff Brian Gardner awarded Deputies Shawn Ireland and Casey Sanders and Sgt. Andy Humphrey the Medal of Valor for saving a life, and in doing so displaying outstanding courage while placing their own lives in danger. Additionally, Sheriff Gardner awarded Deputies Alan Johnson and Bradley Campbell the Life Saving Medal for the act of saving a life.

Thanks, Ray. We love you.


The Life of Dr. Ray Pugh

Ray Pugh died on Dec. 23, 2012, surrounded by family. He passed peacefully, after many years of heart trouble. He was born in Des Moines on February 28, 1929, and graduated from Roosevelt High School. Dr. Pugh earned his physical education degree from Central College, where he was awarded the Schilder Trophy as the

outstanding football player in 1951. He received his Masters from Drake University in 1958, and his PhD from Iowa State University in 1968. He was a school teacher and coach at Garden Grove, Monroe, Johnston, and North High School, and vice principal at Callahan Middle School. In 1970, he began a 26-year career as a professor of physical education and recreation at Drake University.

Dr. Pugh served in the U.S. Army during the Korean War, and was a 50-year member of the Masonic Lodge.

He worked as a leader at the Des Moines YMCA Camp while in high school and college, and was director of the Beaver Valley Day Camp, the Larry Jo Ranch, and the 4-H Camp. He became Y Camp executive director in 1970, and retired in 1991 after 22 years working with the kids.



Dr. Pugh was the straight man for the entertainment groups known as the Three Jacks and a Queen, the Little Stinkers, the Plaid Lads, and the Good Time Gang, who entertained at schools across the state for more than 50 years.

He was a well-known motivational speaker, and gave more than 150 commencement speeches. He wrote several books, including one of favorite quotes such as, "The more you give, the more you live!" He also wrote the musical, "The Home Front," based on his youth when he put on shows to raise money for W.W. II efforts. The show was performed by several groups of students in the 2000s.

He received many awards over the years from numerous organizations. The Ray Pugh Institute of New Hope hosts speakers with inspirational messages that are in the spirit of Ray's positive attitude and joy of life.

Dr. Pugh met the love of his life, Doris Ruth (Dodee) Morris in Lorhville, Iowa. Retired Mitchell County Sheriff Served Iowa 50 Interesting Years

After serving four years of active military duty, I returned home in September 1959. Interested in outdoor activities, I became involved in the Osage Conservation Club, where I met Deputy Sheriff Rich Jahnel. About 1962, Rich and his boss, Sheriff Duke Angell, asked if I would be interested in working part-time as a Special Deputy at the Mitchell County Fair. The job sounded interesting and I accepted. That was the first time I pinned on the badge.


Nineteen sixty-four was an election year, and Sheriff Angell announced he would not seek re-election. Two months before the general election, Rich Jahnel was appointed sheriff to fill out Duke's unexpired term. That same day, Rich hired me as his deputy.

In those days I was not *a* deputy, I was *the* deputy – the only one. Most of the training a rookie deputy received was on-the-job. Rich did send me to a two-week school at the University of Iowa. As training went, it didn't amount to much; But it was better than nothing.

The experience of serving as a deputy sheriff in those days was a lot different than it is today. One of the big differences was there were fewer rules. A deputy nearly always worked alone, and had to develop the ability to exercise independent judgment in a wide variety of situations. Then, as now, an error in judgment would invariably land one in hot water.

Sheriff Jahnel and I each owned our own patrol cars back then. The county paid us eight cents per mile to drive our cars for official business. Out of the eight cents, we had to make car payments, buy gas, make repairs and all the rest. My first patrol car was a 1962 Chevrolet Impala V8. We also had to buy our own uniforms, side arms and other related equipment. The county furnished each of us with a shotgun. If I remember right, I was paid \$350 per month. There was no such thing as overtime pay, holiday pay or anything of the kind. To get a little time off, Sheriff Jahnel and I would take every other Sunday off – if nothing much was going on.

Sheriff Jahnel lived in an apartment at-

tached to the jail. His wife, Mary, and his seven daughters answered the phone, fed the prisoners, washed the laundry and did anything else that needed doing. On the rare occasion when Rich and his family took a vacation, I slept in his bed and ran the jail until they returned.

In those days, there was no ambulance service in the county. If someone was hurt so bad we couldn't haul them in a patrol car, the funeral home would come out and take the injured to the hospital in a hearse. There was no communications center, either. The night nurse at the hospital used a two-way radio to talk to us, when needed.

Court reorganization in the 1970s resulted in the elimination of the Justice of the Peace (JP) courts. The JP courts had been around almost forever. In Mitchell County, JPs were not attorneys and were not trained in the law. The communities of Osage, St. Ansgar, Stacyville and Riceville each had a Justice of the Peace. The JP's job was to handle misdemeanor criminal cases as well as some civil cases.

Arresting someone in the middle of the night and taking them before a JP was quite an experience. The JP would get out of bed and hold court in his or her home. Many times I saw JPs in pajamas hold court right at their kitchen table. If a defendant wanted a jury trial, it was held in the courthouse. The JP would send me downtown to find six jurors. I would usually go to a tavern on Main Street where there was always a bunch of old guys sitting around playing cards. I would get six of them to follow me back to the courthouse for the trial, and they were always willing to serve because they would get a couple of bucks for doing it. The JPs did the best they could in those days, but the magistrate system we have now is much, much better. Outwardly, reorganization did not change the District Court very much.

Looking back, it seems like I spent a lot of time in that Court. I got to know most of the judges who came to Mitchell County. They were all dignified, very able gentlemen. One in particular, Judge B.C. Sullivan, sticks in my memory. Judge Sullivan was not a large man physically, but he had a presence in the courtroom that was remarkable. When B.C. was on the bench, he was absolutely formidable. I remember one trial very well. It was a very boring civil case right after lunch, and the courtroom was quite warm. The lawyers droned on and on, and some of the jurors began to nod off. Suddenly, the unmistakable sound of snoring filled the courtroom. All talking stopped. You could have heard a pin drop. It was almost as if the world had stopped turning. The Judge had fallen asleep. Nobody present was foolish enough to wake him up. After a few minutes, he woke up on his own, and the trial continued as though nothing had happened.

The anti-war movement and social unrest of the late 1960s and early 1970s created a demand for much better local law enforcement. To meet this demand, the federal government began programs allowing cities and counties to hire and train additional officers. Sheriff Jahnel took advantage of the federal funding available and hired four more deputies. Counting myself, that made a total of five. We still operate with that number today.

Around the same time, there were two other things in the works that would have a dramatic influence on all of the sheriffs' offices in Iowa. The first was the establishment of

the Iowa Law Enforcement Academy. The Academy sets the standards for the hiring of officers, and provides the formal training for them to become certified to work as lawmen in Iowa.

The second big change resulted from the beginning of civil service for deputies. Prior to civil service, most deputies lost their jobs when a new sheriff took office. There was no incentive for a deputy to get the training needed or consider making law enforcement a career, because they had no job security whatsoever. Now, when a new sheriff takes office, he inherits all of the deputies. This benefits the officers and the people of the county.

Looking back over the years, I remember being a deputy sheriff was always interesting, frequently exciting - sometimes way more exciting than I wanted it to be. In some instances, I had to take risks and face dangers that seem foolhardy today. For example, one day a man was threatening people with a gun, and shots had been fired. I was working alone that day. When I pulled into the driveway, I noticed several people hiding behind trees and cars. They were pointing toward the house and hollering, "He's in there! He's in there!" There was not much I could do except try to get the gun away from him - hopefully without anyone getting hurt. As I approached the house, I could see through the kitchen door window a man with a rifle walking around inside. I opened the door, walked in and grabbed the rifle out of his hands. That was the way we did it back then. My situation was not unique. All of my brother officers did the same kind of things. Somehow we met, and overcame, the many challenges law enforcement presented.

In early 1984, Sheriff Jahnel announced his retirement. I ran for the office and campaigned throughout that summer. In the November election I was fortunate enough to win. I took the oath of office on January 2, 1985. Being a deputy sheriff is excellent training for becoming the sheriff, but there are a multitude of concerns that fall on the sheriff's shoulders that prior experience as a deputy cannot really prepare a person for. Among other things, budgetary matters are, of necessity, a great concern to the sheriff. The amount of law enforcement a sheriff can give to the people is determined, to a large degree, by the amount of money in his budget.

In the early summer of 1985, I had

been sheriff for a few months and I guess I thought I was pretty hot stuff. I had survived a rather contentious race for the office I now held, and I thought I had a pretty good grip on things. One nice warm day I had reason to drive out to a residence west of Osage. I was in uniform with the window rolled down. I knew the family quite well, and as I pulled into their driveway I saw their seven-year-old daughter running toward the house shouting, "Mama, Mama, here comes Curt and he's wearing his costume!" That little incident reminded me that even though being sheriff was serious business, I should not take myself too seriously. For me, it was both humorous and humbling.

When I became sheriff, one of the first things I came to realize was that I could no longer spend the time out of the office that was necessary to investigate criminal cases. When people come to the Sheriff's Office to talk to the sheriff, they want him to be there - not out running around the County. An older, wiser sheriff once told me, "Curt, the real danger in law enforcement does not come from knives, bullets or car wrecks. The real danger comes from seeing too many things that are not good for you to see." I have found that to be true. The cumulative effect of too much blood, too many bodies, too much witnessing the terrible things people do to each other has really changed me. I am not the same person I was when I started in law enforcement.

I try to not remember, or relive, the bad things I have seen. Instead, I try to focus on the many good things, like the times a small child or an elderly person gave me a smile in gratitude for some small kindness I was able to do for them.

One question I am asked more than any other, usually by kids, is "What is the most dangerous situation I have ever been in?" I think they expect me to tell them about some heroic feat of daring-do that would make me look like the greatest, bravest man that ever lived. I usually smile and tell them I nearly choked on my donut once! Another common question is, have I ever shot anyone? My answer is "No, but more importantly, no one has shot me!" Quite possibly the high point of my career was the successful campaign to get a new Sheriff's Office built. With a lot of help from some very determined people, we were able to get the job done. This building should be here to serve Mitchell County for many, many years.

Being sheriff is very special. I am the 22nd sheriff to serve Mitchell County over the last 158 years. What makes a sheriff so special? For starters, you need to realize the sheriff is the only lawman, at any level of government, who is elected by you, the people. That means the sheriff answers directly to you. You can walk into your sheriff's office with any concern you may have, and expect the sheriff to address your concern in a professional manner without delay. If your sheriff does not meet your expectations, you can select someone else to be your sheriff at the next election.

Another thing... How many times have you witnessed some fool doing something so outrageous and so dangerous that you wished you had a badge and could take some action yourself? Well, guess what? I've got a badge and I can do something on your behalf. Even better, I have five deputies who are ready, willing and able to assist. Together, we can and do strike the blows that need to be struck. I think being sheriff is the best job in the world. I wouldn't trade all I have experienced for anything. From the bottom of my heart, I want to thank the people of Mitchell County for giving me the opportunity to serve. All too often we hear people criticize those of us in public life. I believe there is no higher calling than public service, I am proud to have been a part of it for so many years.
